



## 2019 Sullivan Golf Course Memberships



Sullivan Golf Course will have 3 Membership offerings for 2019 with two types in each offering. **The PREMIUM Membership will allow for play 7 days a week at anytime.** **The SELECT Membership allows for play Monday-Friday (excluding holidays) at anytime and after 12:00 noon on Weekends & Holidays.** Both include unlimited greens fees, cart fees, and range balls for their applicable days of the 2019 calendar year and 15-day advance tee time reservation requests. In addition, all Sullivan Golf Course Members will receive reciprocal privileges, on their applicable days, at the following Walters Golf Management golf courses: \*Gateway National Golf Links, Stonewolf Golf Club, Far Oaks Golf Club, Normandie Golf Club, Innsbrook Resort & Golf Club, The Prairies of Cahokia Golf Club, Woods Fort Golf Club and Arnold Golf Club. A reciprocal fee of \$19.99 is required at most courses and a fee of \$24.99 is required at Gateway National, Stonewolf & Far Oaks, whether walking or riding. All tee times for reciprocal courses must be made through the Sullivan GC Golf Shop and can be made 1 day in advance of the tee time unless Sullivan GC is closed for a golf tournament in which case a reciprocal tee time can be made up to 3 days in advance. **\*Sullivan Golf Course reserves the right to close the course at any time for outside bookings or outings.**

Memberships are available in the following categories, all are valid thru 12/31/19, and all are available only with payment in full. Note: tax is only applicable to the golf portion of membership.

**PREMIUM** Members may play at anytime\* Sunday-Saturday.

**SELECT** Members may play anytime Monday-Friday (excluding Holidays) and after 12:00 noon on Weekends & Holidays

### INDIVIDUAL

Purchase by January 31, 2019 and pay only

**(PREMIUM) \$1,295 + tax = \$1,353.11**

**(SELECT) \$995 + tax = \$1,039.65**

Purchase after February 1, 2019 and pay

**(PREMIUM) \$1,495 + tax = \$1,562.09**

**(SELECT) \$1,195 + tax = \$1,248.63**

### COUPLES (Couples Membership available to husband & wife or significant others in same household)

Purchase by January 31, 2019 and pay only

**(PREMIUM) \$1,795 + tax = \$1,875.55**

**(SELECT) \$1,295 + tax = \$1,353.11**

Purchase after February 1, 2019 and pay

**(PREMIUM) \$1,995 + tax = \$2,084.53**

**(SELECT) \$1,495 + tax = \$1,562.09**

### FAMILY (Family Membership includes children living at home, age 23 or younger)

Purchase by January 31, 2019 and pay only

**(PREMIUM) \$1,995 + tax = \$2,084.53**

**(SELECT) \$1,495 + tax = \$1,562.09**

Purchase after February 1, 2019 and pay

**(PREMIUM) \$2,195 + tax = \$2,293.50**

**(SELECT) \$1,695 + tax = \$1,771.06**
